name and description brought said City, or any officers of said City, for or on account of any injuries or damages  
received or sustained by any person in consequence of or resulting from any work by said principal \_\_\_\_\_

and with the terms of the permits that may be issued to him, and shall also pay all fines imposed upon him for  
violation of any such rule or regulations: then this obligation shall be of no effect: otherwise, it shall remain in full  
force and virtue.
