

**INDEMNITY BOND

**Know all Men by these Presents:**

To the which payment, well and truly to be made and done, we the said Obligor do bind ourselves, and each of us, our heirs, executors, administrators, successors and assigns and each and every of them, for and in the whole, firmly by these presents.

**THE CONDITION OF THIS OBLIGATION IS SUCH THAT**

Whereas, the above named Principal has, upon his application, received a license as a sidewalk and curb contractor pursuant to the provisions of the ordinance relating to the construction of sidewalks for the said Town of Hamden from the Board of Selectmen, authorizing said Principal to engage in the work of constructing, relaying and repairing sidewalks, curbs or combined curbs and gutters, and

Whereas, the said Principal does hereby agree to faithfully perform and construct all said work in accordance with all of the terms and provisions of said sidewalk ordinance and the rules and regulations adopted pursuant to the provisions thereof and to fully comply with all other provisions of said sidewalk ordinance in regard to said work, and

Whereas, the said Principal has agreed to indemnify and save harmless the said Town of Hamden of and from any and all claims and actions of every kind and description that may be brought against said Town of Hamden for or on account of any injuries or damages received or sustained by any person caused by, or resulting from the construction or repair of a sidewalk, curb or combined curb and gutter by said Principal, his servants, agents or employees, or of or from any act or omission in performing said work, and

Whereas, the said Principal has agreed to comply with the terms of the permit issued to him pursuant to said sidewalk ordinance and pay all fines imposed upon him for violating any of the provisions of said sidewalk ordinance.

Now, Therefore, if the said Principal shall well and truly perform all of his agreements herein above recited and fully discharge his obligations thereunder, then this bond shall be void, otherwise to remain in full force and effect.
