WHEREAS, the Principal is required under the provisions of Article XXI, Section 70-199 of the Code of the Town of North Hempstead during the aforesaid period, to save and keep harmless the Town of North Hempstead from all damages, liabilities, losses or judgments that may be recovered against the Town by reason of negligent erection or maintenance of any ground sign, billboard, wall sign, tower sign, gasoline station sign and marquee, erected or maintained under said license, and/or to reimburse the Town for any removal expenses caused by the failure of the Principal to remove any such sign.

NOW, THEREFORE, the condition of the above obligation is such that if the Principal shall faithfully observe the above stated requirements of Article XXI, Section 70-199 of the Code of the Town of North Hempstead, then this obligation shall be void; otherwise to remain in full force and effect.

PROVIDED, the aggregate liability of the Surety to any and all persons, regardless of the number of claims made against the bond or the number of years the bond remains in force, shall in no event exceed the amount set forth above. Any revision of the bond amount shall not be cumulative.
