THE CONDITION OF THE ABOVE OBLIGATION IS SUCH, that if the above bounden _____, who has this day been licensed or is about to be licensed for the year _____, ending **December 31st** _____, to make openings into sewers, drains, or water distribution systems in the INC. VILLAGE OF HEMPSTEAD for the purpose of making connections therewith from any house, cellar, vault, yard of other premises, will carefully make the openings into any such sewers, drains or water distribution systems in the manner prescribed by said INC. VILLAGE OF HEMPSTEAD without injuring them and will leave no obstruction of any description whatever therein; will properly close up said sewers, drains, or water distribution systems, around the connections made by him, and will make no openings into the arch of any sewer, drain or water distribution system, and will faithfully comply with the ordinances in relation to opening and excavating of streets, and with all the rules and regulations of the office of INC. VILLAGE OF HEMPSTEAD and will save, indemnify and hold harmless the said INC. VILLAGE OF HEMPSTEAD, of and from any and all injury that may accrue to persons, animals or property and damage consequent thereupon by reason of an opening in any street, lane, avenue, or public place made by him or by those in his employment, for the purpose of putting down any service pipe or pipes for the introduction of water, or for making any connection with any public or private sewer, or for any purpose or object whatever, and will deposit the material composing the superstructure without breaking or injuring the same in a manner which will occasion the least inconvenience to the public, and will fill in any excavation made, and leave the same properly packed, rammed and repaired for the paving required, and suitably restore the payment taken up for excavation, then this obligation to be void; otherwise remain in full force and effect.

THE SURETY AGREES to pay the INC. VILLAGE OF HEMPSTEAD for the repairs to be made by the Village as a result of said opening if the Principal fails to make payment of any bill within thirty days after receipt of said bill by the principal from the Village, such payment to be made whether the work has been done or is to be done by the Village and whether said bill has been sent more or less than one year after the date of such opening.
