NOW THE CONDITION OF THIS OBLIGATION IS SUCH: That if the said

Principal hereinbefore named, his, their, or its heirs, executors, administrators, successors or assigns, in laying or
repairing or connecting water mains, pipes, surface lines, or performing other work in the sidewalks, streets, roads,
lanes and ways in said City of Pittsburgh, requiring a permit from said City of Pittsburgh for the opening thereof, shall
properly protect and guard all excavations made by him, them or it, and place lights or warnings while so laying or
repairing or connecting or excavating or performing any such work and erecting such pipes, together with the curb or
gate valve boxes, so that the top thereof shall be flush with the surrounding ground, and shall forthwith restore at his,
their, or its expense, the earth, pavements, streets, roads, lanes, ways, and any sewer connections, manhole covers,
drains or castings, in so far as the same have been disturbed by said Principal, in the same condition in which they
were before being so disturbed, and keep the same at his, their, or its expense in good repair for
_____ from the date of the permit issued for the same by the City of Pittsburgh; and provided

further, that if said _____

Principal, his, their, or its heirs, executors, administrators, successors or assigns, respectively, shall indemnify and
save harmless the City of Pittsburgh, its successors and assigns, from all loss, damages, costs, charges, excess
yardage charges, increased permit charges, applied permit charges, and expenses whatsoever in any manner
occasioned by or arising from the opening, repairing, excavating or disturbing of any sidewalks, streets, roads, lanes
or ways in the said City of Pittsburgh; and provided, further, that if said

harmless the City of Pittsburgh, its successors or assigns, from all damages, costs, charges, and expenses for which
