will maintain such cement sidewalks when so built or constructed for a period of two (2) years free of any cost or charge to the owner thereof, and
will keep and observe all ordinances, rules and regulations at any time enacted by the City of Beaumont relating to the building and construction of
sidewalks in the city limits of the City of Beaumont.

All remedies upon or under this bond shall be in addition to and cumulative of all other remedies the parties may have at law or in equity for
recovery of any such losses or damages. Cumulative recoveries may be had on this Bond but total recoveries hereunder by all claimants shall not exceed
Two Thousand (\$2,000.00) Dollars. Principal will maintain this bond at Two Thousand (\$2,000.00) Dollars by providing the City of Beaumont
with additional bond principal within fifteen (15) days after any recovery is made on this bond.
