PLUMBING CONTRACTORS BOND

KNOW ALL MEN BY THESE PRESENT: THAT we, _____
as Principal, and _____ is hereby, authorized under the laws of
the State of Texas to act as surety on bonds for principals, as surety, are held firmly bound unto the City of Beaumont a municipal corporation of
Jefferson County, Texas, in the sum of Five Thousand (\$5,000.00) Dollars good and lawful money for the payment of which we hereby bind
ourselves, our heirs, executors, administrators, successors and assigns jointly and severally by these presents:

WHEREAS, Section 6-4 of the Code of Ordinances of Beaumont, Texas, requires a bond in the sum of Five Thousand (\$5,000.00) Dollars
of persons or businesses pursuing contracting within the City of Beaumont.

NOW THEREFORE, the condition of this obligation is such, that if the said principal will faithfully observe all the laws pertaining to
plumbing, drain laying, blasting and excavating; and that if the said principal shall indemnify and save harmless the City of Beaumont Texas from
all claims arising from accidents and damages of any character whatsoever caused by the negligence of said principal, his agents, or employees, by
any other unfaithful, inadequate work done by said principal, his agents or employees; and that said principal will maintain in a safe condition for a
period of one (1) year all ditches and excavations which may be opened in the performance of any plumbing work and further that all dirt and other
material excavated will be replaced in good condition with similar materials, provided that where any such excavation is made in an unpaved street,
or any street paved with chert or macadam, the word "street" as herein used, shall apply to sidewalks, curbs, gutters, and street paving, then this
obligation shall be null and void; otherwise to remain in full force and effect.

All remedies upon or under this bond shall be in addition to and cumulative of all other remedies the parties may have at law or in equity
for recovery of any such losses or damages. Cumulative recoveries may be had on this Bond but total recoveries hereunder by all claimants shall not
exceed Five Thousand (\$5,000.00) Dollars. Principal will maintain this bond at Five Thousand (\$5,000.00) Dollars by providing the City of
Beaumont with additional bond principal within fifteen (15) days after any recovery is made on this bond.

This obligation shall continue in full force and effect for the period of one (1) year from the date of approval and filing hereof.
