### Cement Sidewalk and Approach Bond

THE STATE OF TEXAS

KNOW ALL MEN BY THESE PRESENTS: COUNTY OF TARRANT

That we, \_\_\_\_\_, as Principal, and

\_\_\_\_\_, as Surety are held and firmly bound unto the City of Bedford, Texas and/or any person, firm or corporation injured by a breach of the terms hereof, \$2,500.00 (Two Thousand Five Hundred Dollars and No Cents) for the payment of which well and truly to be made, we and each of us hereby bind ourselves, our heirs, executors, administrators and successors, jointly and severally, firmly by these presents:

The Conditions of this obligation are such that, whereas, the above Principal desires to engage in the business of laying, constructing, building, repairing and rebuilding curbs, gutters, sidewalks and approaches on the Right of Way in the City of Bedford, Texas, the construction and installation above set forth shall be performed according to the City of Bedford Street and Drainage Specifications Ord. #458; and such construction and installation and the location thereof shall be approved by the Director of Public Works or his designated representative of the City of Bedford, Texas, prior to beginning work.

NOW, THEREFORE, if said Principal shall during his continuance of said work indemnify and save harmless said City of Bedford, Texas, and/or any person, firm or corporation, from any and all damages of every character arising from, or caused directly or indirectly by an negligence in the doing of such work as above set forth under the terms of said Ordinance or for any imperfect or inadequate work done by said Principal under the terms of said Ordinance and said Bond, and shall maintain said work in good and workmanlike state of repair for and during a period of two (2) years from and after its completion and acceptance by said City of Bedford, Texas. Successive actions may be brought on this bond for successive breaches of its condition. The Liability of the Surety under this bond if not canceled as hereinafter provided shall cease and determine of its own force and effect one (1) year from the date hereon, saving and excepting for the maintenance for work performed prior to the date of termination, and for which work the liability of the Surety for maintenance shall continue for one (1) year from and after the date of the completion and acceptance of said work by the City, but no longer.

The Surety may terminate its liability under this bond at any time, by giving the City Council of the City of Bedford, Texas, five days notice in writing of Surety's intention to do so. From and after said date, the Surety will no longer be liable for any subsequent act of the Principal.
