KNOW ALL MEN BY THE THESE PRESENTS:

Now, therefore, the condition of this obligation is such that, if said Principal shall well and faithfully observe and obey all laws, rules, ordinances, and regulations whatsoever prescribed by the City of Kerrville, Texas with respect to the provisions and regulations of associated codes, then this obligation shall be null and void, otherwise to remain in full force and effect.

It is understood and agreed that the Surety may cancel this bond at any time on thirty days (30) notice in writing to the City of Kerrville, Texas, but is hereby expressly provided that such cancellation shall not affect any accrued liability on this bond. Venue for any disputes or claims arising from or related to this bond shall be in Kerr County, Texas.

The term of this bond shall be effective for one year from the date hereof, and may continue in force for one additional year term by the execution of continuation certificate(s) by the Surety, or its properly authorized agent. A similar certificate may be provided to the obligee each year thereafter, binding the Principal and Surety in accordance with the terms of the bond.
