## HOME IMPROVEMENT CONTRACTOR'S/SALESMAN BOND

KNOW ALL MEN BY THESE PRESENTS:

That we, \_\_\_\_\_ as principal, \_\_\_\_\_ as surety, are held and firmly bound unto the City of Kirby, in the sum of Five Thousand (\$5,000.00) Dollars for the payment of which to be well and truly made unto the said City of Kirby, we bind ourselves, our heirs, executors and administrators, jointly and severally, firmly by these presents.

Conditioned that the above bounden \_\_\_\_\_ will duly observe the regulations and specifications of all ordinances regulating and referring to the manner of all installations of and work done within or on Public and private buildings and premises; and will observe all the health, sanitation and safety ordinances and Building Codes and Ordinances of the City of Kirby, and will pay all fines imposed by the Municipal Court for violation of any of said ordinances and also conditioned that the bounden \_\_\_\_\_ will indemnify and save harmless the City of Kirby for six months after the work is done in regard to any cost consequent upon any act or negligence of him/her self or any of his/her employees in doing said work, or in the City in repairing same if same has to be required and to indemnify and hold harmless the City from any liability or damage occurring to persons or property by reason of neglect of any of the aforementioned ordinances or any defect in said work at any time appearing and the inspection and passing of the work by the City Authorities shall not in any way particular be deemed a waiver of any condition herein; and further conditioned for the faithful performance of all work entered upon or contracted for, and in strict accordance and compliance with terms, requirements and provisions of the Kirby City Code; and further conditioned that the contractor shall, without additional cost to the person, firm or corporation for which such contract work is done, correct any defect due to faulty or incomplete workmanship, materials or noncompliance with the provisions of the code. Such corrections shall be accomplished within seventy-two (72) hours after receipt of notification by the city building inspector.

Now if the said \_\_\_\_\_ shall well and truly observe the said regulations and specifications and pay all fines imposed upon him/her by said Municipal Court for violation of said ordinances then this obligation shall be null and void, otherwise to remain in full force and effect.

Notifications of surety cancellation or reduction in the amount of surety shall be given in writing to the City Secretary of the City of Kirby, to become effective at 12:00 noon after five (5) consecutive working days of receipt by the City Secretary of such notification.

This bond and obligation shall otherwise continue in full force and effect from the date of its approval by the Building Inspector of the City of Kirby until the last day of December \_\_\_\_\_, and shall be subject to successive recoveries within the sum above limited.
