WHEREAS, it is further specially provided that the principal shall fully and faithfully perform and discharge all the duties and obligations required of him as a contractor and shall indemnify and pay all persons for any and all damages that may accrue to their persons or property by virtue of any permit issued by the City under this ordinance, and said person(s) shall have the right to proceed against the principal without the joinder of the City, and just as though originally names herein.

WHEREAS, it is understood and agreed that should the principal, in all things comply with his obligations, duties, conditions, promises and undertakings as herein provided, then this obligation shall become null and void, otherwise to remain in full force and effect. Further, should the principal fail, neglect or refuse in any respect to comply with his said obligations or duties, conditions, promises and undertakings, the City may, at its option, cancel this bond and all permits issued to the principal in connection, herewith, without prejudice to any of the legal rights and remedies it or any other person(s) may have reason of the execution hereof.
