

**BOND FOR OPERATION OF OVERWEIGHT OR OVERSIZE VEHICLE  
IN MONTGOMERY COUNTY, TEXAS\*\*\*\*\*  
(ONE YEAR BOND)**

**STATE OF TEXAS** (

**COUNTY OF MONTGOMERY** (

**KNOW ALL MEN BY THESE PRESENTS,**

That we, \_\_\_\_\_ of \_\_\_\_\_  
County, Texas, hereinafter called "Principal", and \_\_\_\_\_, a surety company authorized to  
do business in the State of Texas, hereinafter called "Surety", are held firmly bound unto the County Judge of  
Montgomery County, Texas as Oblige in the amount of \_\_\_\_\_ DOLLARS(\_\_\_\_\_) for the payment  
whereof Principal and Surety bind themselves, their heirs, legal representative, successors and assigns jointly and  
severally, firmly by these presents.

**WHEREAS**, Principal has made application to Montgomery County, Texas for a Permit to Move  
Super Heavy or Oversize Equipment or Load Over County Roads, and

**WHEREAS**, the obligation undertaken by Principal and Surety herein is a condition precedent to  
the issuance of such permit,

**NOW THEREFORE, THE CONDITION OF THIS OBLIGATION IS SUCH**, that should  
such Principal cause damage to any public street, road, highway or bridge within the geographical confines of  
Montgomery County, Texas, (other than State highways or public roads within the boundaries of an incorporated  
municipality) which damage results or arises out of the use, operation or movement by Principal, its employees or  
agents, of a vehicle weighing in excess of the weight limit for such public street, road, highway or bridge as  
established by the Commissioners' Court of Montgomery County, Texas (hereinafter called "overweight vehicle")  
or being in excess of the width, length, and height limitations established for vehicles by Article 6701d R.C.S.  
(hereinafter called "oversized vehicle"), then Principal and the Surety hereon agree, bind and obligate themselves  
to pay the County Judge of Montgomery County, Texas, for the use and benefit of Montgomery County, Texas all  
loss or damage to it occasioned by reason of the use, operation or movement of such overweight or oversized  
vehicle.

This bond shall be effective on and from the date of its approval by the County Judge of  
Montgomery County, Texas and shall continue in full force and effect for a period of one year, at which time  
this obligation shall become void, provided however, should any public street, road, highway or bridge within the

scope of this agreement sustain any loss or damage resulting from use, operation or movement by Principal of an overweight or oversized vehicle then this obligation shall not expire but shall remain in full force and effect and Montgomery County, Texas may institute suit under this bond at any time prior to four (4) years from the date of the expiration of the one year period set forth hereinabove.

In the event of suit hereunder, venue shall lie in Montgomery County, Texas. This agreement shall be interpreted according to the laws of the State of Texas.
