SURETY, duly authorized and qualified to do business as a surety company in this state, are firmly bound unto the **STATE OF TEXAS** in the sum of **FIVE THOUSAND AND NO/100 DOLLARS (\$5,000)** payable at Austin, Travis County, Texas, to the State of Texas for all judgments recovered against the **PRINCIPAL** for any wrongful or illegal act committed by the **PRINCIPAL** in the course of administering a polygraph examination, and for the payment of which, well and truly to be made, we bind ourselves, our heirs, successors and assigns, jointly and severally, firmly by these presents.

This bond is to remain in full force and effect subject to the following terms and conditions:

1. It is agreed that as of _____ this bond shall be in full force and effect and remain in effect until cancelled by the **SURETY**.

2. This bond is open to successive recovery, but in no event shall the aggregate liability of the **SURETY** under this bond exceed the face value of this bond.
3. The **SURETY** may at any time cancel this bond by giving thirty (30) days written notice to the Texas Department of Licensing and Regulation. The **SURETY** remains liable for any default under this bond committed prior to the expiration of such thirty-day period and the bond shall be maintained until the expiration of two years after the **PRINCIPAL** ceases to be licensed as a polygraph examiner.
4. Any person injured or aggrieved by any violation of this law by the **PRINCIPAL**, or his or her agents or representatives, is entitled to bring suit on this bond.
