

PLUMBER AND GAS FITTER'S BOND
(FORM PRESCRIBED BY CITY LAW DEPARTMENT 4-9-90)

KNOW ALL MEN BY THESE PRESENT: THAT WE, _____ as Principal, and _____ as Sureties, a corporation duly licensed to do business in the State of Texas are held and firmly bound unto the City of Port Arthur, Texas in the sum of Two Thousand (\$2,000.00) Dollars for the payment of which, well and truly to be made, we hereby bind ourselves, our heirs, executors, administrator assigns, and legal representatives firmly by these presents:

THE CONDITION OF THE ABOVE OBLIGATION IS SUCH THAT:

Whereas, the above-named Principal is engaged in the business of plumbing and gas installation, both existing and new, extension, alteration, repair, replacement, drains, vents, and appurtenances, within or adjacent to any building or structure within the City of Port Arthur, Jefferson County, Texas; and

Whereas, Section 103 of the City of Port Arthur Plumbing Code, and Section 103 of the Gas Code of the City of Port Arthur, requires a bond in the sum of Two Thousand (\$2,000.00) Dollars of every person pursuing such occupation within the City of Port Arthur, which said Section 103 of the Plumbing Code and Section 103 of the Gas Code are made a part hereof for all intents and purposes.

NOW THEREFORE, if the said Principal shall sufficiently indemnify and hold harmless the City of Port Arthur and all employees against all costs, expenses, or damages which may in any way accrue against the City of Port Arthur and all employees on account of his failure to conform to the regulations of the aforesaid Plumbing and Gas Codes and other ordinances of the City in reference to buildings, plumbing and gas and shall pay all loss and damage for injuries to persons and property which may lawfully be claimed against him on account of such negligence or failure, then this obligation shall be null and void; otherwise it shall remain in full force and effect.

This Bond shall cover all installing, maintaining and alterations of water or gas piping, sanitary drainage and vent system, plumbing and gas fixtures or vents, within or adjacent to any building or structure within the City of Port Arthur, Texas, and by the named principal within the City of Port Arthur, for the period of one (1) year commencing _____ day of _____, 20____, and ending on the _____ day of _____, 20____, unless renewed by a continuation certificate.

This Bond shall also insure to the benefit of any and all persons who sustain any loss or damage on account of any failure by said named Principal to conform to the regulations of the aforementioned Section 103 of the Plumbing Code and Gas Code, and other ordinances of the City in reference to buildings, and any such person sustaining any such loss or damage may bring suit on this Bond against the principal and surety or sureties herein in any court of competent jurisdiction to recover same.

All remedies upon or under this Bond shall be in addition to and cumulative of all other remedies the parties may have at law or in equity for recovery of any such losses or damages. Cumulative recoveries may be held on this Bond to the full amount thereof.
