**PLUMBER'S BOND**

KNOW ALL MEN BY THESE PRESENTS: That we, \_\_\_\_\_  
of said County and State, as Principal and \_\_\_\_\_ as sureties, are held and  
firmly bound unto the City of Port Neches, Jefferson County, Texas in the penal sum of TWO THOUSAND DOLLARS (\$2000.00) good  
and lawful money, for the payment of which to the said City of Port Neches, or its successors, we bond ourselves, our heirs, executors  
and administrators.

The condition of this obligation is such that, whereas, the said \_\_\_\_\_  
is engaged in the occupation business and calling of a plumber in the City of Port Neches, and in carrying on such work may, under  
permit issued under the Ordinances, Rules and Regulations of the City of Port Neches, Texas make connections with the public sewers  
in said City, test the mains and laterals, at such point as may be allowed by Ordinance, or by the permission of the lawful authorities;  
that this obligation shall protect said City of Port Neches, Texas against all loss and damage occasioned by the negligence of the said  
\_\_\_\_\_ in failing to properly execute and protect all work done by him  
or his employees, or under his direction or supervision and from all loss or damage occasioned by or arising in any manner from any  
plumbing done by said \_\_\_\_\_ or his employees, or under his  
direction or supervision, which is not caused by the negligence of said City or its agents or employees, and that said  
\_\_\_\_\_ herein will keep and observe all ordinances at  
any time enacted by said City relating in any way to plumbing work.

NOW, THEREFORE, in above bounden \_\_\_\_\_ shall keep the above  
conditions, shall properly execute and protect all plumbing work done in the City of Port Neches, Texas either by himself or through his  
employees, or under his direction or supervision, and if the above bounden \_\_\_\_\_ shall  
keep and observe all ordinances at any time enacted by said City relating to plumbing work, then this obligation shall be null and void,  
otherwise to remain in full force and effect and virtue.

This obligation shall continue in full force and effect until cancelled by the surety and notice of said cancellation is filed with  
the City Clerk of the City of Port Neches, Texas.
