WHEREAS _____

hereinafter termed "PRINCIPAL" is engaging in the business or occupation of Repair & Installation of Heating, Air Conditioning, Refrigeration, Ventilation and Duct Work, in the City of San Antonio, as provided in An Ordinance, passed and approved November 27, 1957, and any amendments thereto; now, therefore,

KNOW ALL MEN BY THESE PRESENTS, that I, (WE) _____

as principal, and the undersigned, as sureties, acknowledge ourselves held and firmly bound and obligated to pay in and unto said City of San Antonio its successors and assigns, the sum of FIVE THOUSAND (\$5,000) DOLLARS.

CONDITIONED, that the principal herein, will comply with all laws of the State of Texas, and all ordinances of the City of San Antonio, with reference to said business or occupation, and will well and truly, promptly and punctually, pay all losses or damage (including all costs and expenses) to person or property which may arise by reason of any work, or labor done, or material furnished by said principal, or any sub-contractor, or person under said principal, their agents, servants and employees, being in violation of, or not in accordance with any law of the State of Texas, or any ordinance of the City of San Antonio, controlling the same; and will, also, indemnify and save harmless, the City of San Antonio, its successors and assigned, and any and all persons, from any and all liability and damage, either to person or property, occurring by reason of negligence of said principal or of any sub-contractor or person under said principal, their agents, servants, and employees.

This obligation is made for the use and benefit of the owner, or any party in interest in the property or premises where any material or labor is furnished by the principal or by any sub-contractor or person under said principal, their agents, servants or employees, and for the use and benefit of any person under said principal, their agents, servants or employees.

This bond and obligation shall continue in full force and effect from the date of its approval by the City Manager of the City of San Antonio until the 31st day of December, _____, and shall be subject to successive recoveries within the sum above limited and suit or suits may be instituted in the name, or names; of any by any party, or parties, who shall suffer loss or damage to person or property by reason of any breach thereof by said principal, this bond, in addition to being given in pursuance of said ordinance, shall be held to be a common law obligation in accordance with its face, tenor and effect; and each surety guarantees that all sureties expected to sign this bond have so signed before same comes into custody of said City.
