KNOW ALL MEN BY THESE PRESENTS, That we, the PRINCIPAL AND SURETY above named, are held and firmly bound unto the CITY OF PORTSMOUTH, hereinafter called the City, in the penal sum of *FIVE THOUSAND* (\$5,000) *DOLLARS* for the payment of which sum well and truly to be made, we bind ourselves, our heirs, executors, administrators, and successors, jointly and severally, firmly by these presents and we hereby waive the benefit of our Homestead Exemption as to this obligation.

The condition of this obligation is such that, if the principal shall conform to and comply with the Building Code of the City and all other ordinances of the City relating to contractors, electricians, gas fitters, plumbers, buildings, fixtures, streets and sidewalks, and shall indemnify and save harmless the City of Portsmouth, its officers, agents and employees, or any other person(s) from all loss of damage by reason of any injury to any person or property occasioned by the negligence, or defective or inadequate work of the principal or his agents, servants or employees in digging up, opening, or in any manner disturbing the surface of any public street, lane, alley, sidewalk, or other public way in the City of Portsmouth, or in failing to safeguard the same, or in failing to comply with said Building Code and the other ordinances relating to contractors, electricians, plumbers, gas fitters, buildings, fixtures, streets and sidewalks, then this obligation shall be void; otherwise, to remain in full force and effect.

This bond cannot be cancelled or changed until thirty days after mailing notice thereof to the principal and to the Building Official of the City of Portsmouth, Virginia, and any such change or cancellation shall not discharge said surety from any liability already accrued under this obligation or any liability which shall accrue before the expiration of the 30 day period.
