BOND OF PERMIT CARRIER

KNOW ALL MEN BY THESE PRESENTS:

THE CONDITION OF THE ABOVE OBLIGATION IS SUCH THAT, WHEREAS, the above bound principal has been granted a permit to transport alcoholic liquors within, into or through the State of West Virginia, in accordance with the regulations of the West Virginia Alcohol Beverage Control Administrator and pursuant to the provisions of the West Virginia Alcohol Beverage Control Act.

NOW, THEREFORE, if the above bound principal shall exercise the privileges granted by said permit in conformity with the provisions of the Alcohol Beverage Control Act aforesaid and the regulations of the said West Virginia Alcohol Beverage Control Administrator adopted pursuant to the provisions of the said Act, then the above obligation shall be void. Otherwise, it shall remain in full force and effect, and the above bound principal shall forfeit to the state school fund the sum of one hundred dollars for each breach of the condition of this bond recoverable by motion upon ten days' notice in any court having jurisdiction of the parties.
