WHEREAS, the condition of the above obligation is such that the above bound principal is about to obtain, in pursuance of the provisions of Chapter 11, Article 16 of the Code of West Virginia, as amended, and the Regulations promulgated by the Commissioner, a Nonintoxicating Beer Distributor's License from the WEST VIRGINIA ALCOHOL BEVERAGE CONTROL COMMISSIONER, to sell nonintoxicating beer from the place of business described in the application of such license

NOW, THEREFORE, if the said principal shall faithfully observe the State of West Virginia Nonintoxicating Beer Act and the Regulations promulgated thereunder by the WEST VIRGINIA ALCOHOL BEVERAGE CONTROL COMMISSIONER, then this obligation is void; otherwise this obligation shall remain in full force and effect, and I the license of the principal shall be revoked, then the full amount of this bond shall be forfeited to the State of West Virginia, and the full amount, when received by the State, shall be credited to the State's General Revenue Fund.

This bond is executed in pursuance of the provisions of said Chapter 11, Article 16 of the Code of West Virginia, as amended, and pertinent provisions of Article and Regulations promulgated by the WEST VIRGINIA ALOCHOL BEVERAGE CONTROL COMMISSIONER are made a part of this bond.
