THE CONDITION OF THE FOREGOING OBLIGATION IS SUCH THAT:

WHEREAS, the above bounden STRUCTURAL CONTRACTOR has on the _____ day of ______, Sought the issuance of a license from the CITY pursuant to Denver Revised Municipal Code Section 339-A for STRUCTURAL work in public, street or alley or other public property of the CITY;

WHEREAS, execution of this bond is a condition precedent to the issuance of such license:

NOW, THEREFORE, if the said STRUCTURAL CONTRACTOR shall and will, in all particulars well and truly and faithfully observe, perform and abide by each and every ordinance relating to constructing bridges, viaducts, public buildings and any and all other public and private structures in the right-of-way or other public property of the City and the Rules and Regulations of the Department of Public Works, according to the true intent and meaning in such ease; and

PROVIDED FURTHER, that if the said STRUCTURAL CONTRACTOR shall satisfy all claims and demands incurred by the STRUCTURAL CONTRACTOR in the performance of any such STRUCTURAL work, and shall fully indemnify and save harmless the CITY from all damages, claims, demands, expense and charge of every kind (including claims of patent infringement) arising from any act, omission, or neglect of said STRUCTURAL CONTRACTOR, its agents, or employees with relation to any work performed under a license; and shall fully reimburse and repay to the CITY all costs, damages and expenses which it may incur in making good any default based upon the failure of the STRUCTURAL CONTRACTOR to fulfill it's obligation to



furnish maintenance, repairs or replacements for the full guarantee period provided in the ordinance, then this obligation shall be null and void; otherwise it shall remain in full force and effect.

This bond may be terminated at any time by the Surety upon sending notice in writing, by certified mail, to the Manager of Public Works of the City and County of Denver, with whom this bond is filed. After expiration of 30 days from the receipt of said notice this bond shall terminate and the Surety shall thereupon be released from any liability, acts or omissions of the Principal subsequent to said date.
