KNOW ALL MEN BY THESE PRESENTS, That we, the PRINCIPAL above named and SURETY above named, are held and firmly bound unto BALTIMORE COUNTY, MARYLAND, in the full and just sum of TWENTY THOUSAND DOLLARS AND 00/100 (\$20,000.00), for the payment of which sum well and truly to be made, we bind ourselves, our heirs, executors, administrators, successors and assigns, jointly and severally, firmly by these presents.

WHEREAS, the PRINCIPAL has made application to the Baltimore County Department of Permits, Approvals and Inspections for a TRESPASS TOWING LICENSE in Baltimore County for an annual term commencing \_\_\_\_\_, \_\_\_\_\_, \_\_\_\_\_ and ending \_\_\_\_\_, \_\_\_\_\_, \_\_\_\_\_; and

WHEREAS, it is a requirement of the Baltimore County Code, Article 21, Title 16, Section 21-16-118(a)(7), as amended, that the PRINCIPAL file with the Director of Permits, Approvals and Inspections a bond in the amount of TWENTY THOUSAND DOLLARS AND 00/100 (\$20,000.00) to guarantee payment of any liability incurred under Article 21, Towing Business of the Baltimore County Code, as amended, and conditioned as hereinafter provided.

NOW, THEREFORE, if the PRINCIPAL shall well and truly perform and properly account, pay and deliver any monies or property entrusted to its care and possession and perform as required under the trespass towing regulation in Article 21, Towing Businesses, of the Baltimore County Code, as amended, while acting as a trespass tower during the term of said license as aforesaid, than this obligation shall be null and void; otherwise to remain in full force and effect.

THIS BOND shall be for the use and benefit of any person, firm, or corporation dealing with the PRINCIPAL as trespass tower, and any such person, firm, or corporation shall have a direct right of action against the PRINCIPAL and the SURETY under this Bond; provided, however, the maximum penal amount of this BOND shall in no event exceed the sum of TWENTY THOUSAND DOLLARS AND 00/100 (\$20,000.00).
