WHEREAS, the above bounden \_\_\_\_\_ has made application to the Board of County Road Commissioners of Muskegon County, Michigan for a permit to install service pipes, conduits and to excavate holes and ditches, etc. or other structures, tunnels and excavations in the right-of-way of a certain County road as stated in the application for said permit.

NOW, THEREFOR, the condition of this obligation is such that the above bounden shall install such service pipes, conduits or structures, or shall make such excavations for holes or ditches or tunnels or structures in the manner prescribed in the permit heretofore issued by said Board of County Road Commissioners, and shall properly maintain and safeguard same while such work and undertaking is in progress and while installing and removing same, and while operating any equipment and machinery and using any materials in and about such undertaking, and shall well and truly pay all damages to the surface of said road, or the shoulders thereof or any highway signs or other appurtenances on and of such road on account of such installation, construction, excavation and operation and maintenance of equipment and machinery and materials, and all other damages, fines, and penalties which he (it) shall become liable to pay together with all charges for engineering, inspection and supervision furnished by the said Board of County Road Commissioners in and about such undertaking, and shall save said Board of County Road Commissioners, and the County of Muskegon harmless and indemnify them and each of them in and about all suits, claims, damages and proceedings of every kind arising out of such undertaking, and shall observe all of the terms and conditions of the permit so issued, or to be issued, then this obligation to be void, otherwise of full force and virtue.

This bond shall take effect as of date hereof and shall continue to be in full force and virtue as to any permit issued to said Principal for the project authorized in the permit heretofore granted to said permittee or any such permit hereafter granted to said Principal during a period of one year from and after the date of this bond unless the Surety herein notifies said Board of County Road Commissioners in writing by registered or certified mail of the cancellation of this bond, however such cancellation shall be so delivered to said Board of County Road Commissioners, as to any one project, prior to the undertaking of said Principal is commenced, and if such undertaking is commenced without prior notification this bond shall remain in full force and virtue until the completion of such undertaking.

It is understood by both said Principal and said Surety that this bond is made as a continuing bond for said period of time to facilitate and expedite the various undertakings of said Principal in the premises.
