OCCUPATIONAL BOND FOR PEDDLING, SOLICITING, AND CANVASSING

KNOW ALL MEN BY THESE PRESENTS: That _____ of

licensee, as principal, and _____, a corporation duly qualified to transact business in the State of Oklahoma, as surety, are held and firmly bound unto the City of Del City, as Municipal Corporation of the State of Oklahoma, for the use of the CITY and of any person or persons who may have a cause of action against the obligor of this Bond under the provisions of the Ordinances regulating peddlers, solicitors, and canvassers, in the sum of One Thousand Dollars (\$1,000.00), lawful money of the United States of America, for the payment of which, well and truly to be made, we bind ourselves, our successors, heirs, executors, administrators and assigns, jointly and severally, firmly by these presents.

NOW, the conditions of this obligation are such that whereas, the above bounded principal obligor has made an application for a license to carry on the business or trade of peddler, solicitor, or canvasser within the City of Del City, for the period of the license paying year within said City, beginning _____, and ending _____, under and pursuant to the requirements of the ordinances of the City of Del City in relation to pawnbrokers or their business, which may now exist or which may be passed by the lawful authorities of said City during continuation of said license, and such ordinances and all other ordinances of said City affecting said occupation are hereby referred to and incorporated in, and all requirements thereunder are hereby made a part of the obligations of this BOND, and are to be performed by the principal hereof as though fully transcribed herein, and that the principal obligor will indemnify and save harmless the City from any and all loss, cost, damages, expense, action or liability of any kind whatever, including reasonable attorney fees, which the City may suffer or be required to pay, or which may accrue against it or be recovered from the City by reason of any loss, damage, or injury incurred by any persons or persons on account of or by reason of the doing of any peddling, soliciting, or canvassing in the City by the principal, his agents, servants, or employees.

NOW, if the said _____, principal obligor shall fully and faithfully perform all the duties appertaining to such occupation fully in accordance with the ordinances herein mentioned while doing or following said occupation or business within the corporate limits of the City of Del City, and if said principal obligor shall, during the term of said license, faithfully comply with all the rules and regulations of the lawful officers of said City, and with all the ordinances of said City and with all the ordinances of said City above referred to, and shall pay all fines and penalties imposed for a violation of any of said ordinances and shall indemnify and save harmless the said City from all damages and liabilities whatsoever, then this obligation be void and of no effect, otherwise to remain in full force and virtue.

NOW, this contract being entered into the City of Del City, Oklahoma, is made under and pursuant to any and all applicable laws of the State of Oklahoma.

NOW, the indemnity bond, and the terms of this contract, shall not be interpreted in any way so as to create any obligations to any third persons on the part of the City of Del City.
